I hope you are all staying safe and well. I am writing with a few resources, reminders, and messages. A lot of emails have been distributed regarding research that I want to summarize and clarify here. Please read this all the way through.

Funding and Payments

Seed funding at the university level is on hold, however, this does **NOT** apply to our internal funding at GSSW (e.g. Summer Mentored Scholarship Award, Internal Support for Faculty Research and Scholarship). Also, start-up funds and externally-funded projects are **NOT** impacted by this hold. Please continue to communicate with Patty and Ali on any grant-related spending. Reach out to me if you have any questions.

Also, all Concur, out-of-pocket expenses, and outstanding contracts need to be reconciled by March 25th so that we can perform internal checks and send our unit approval to central by the 27th.

Please also **make sure that everyone is on direct deposit** if they are not already. If you supervise research staff, please make certain that they are as well:

Consultation and Data Collection Contingency Planning for Human Subjects Data Collection

As all in-person human subjects data collection has been suspended for the safety and wellbeing of all involved. I know from our internal survey that some projects were planning to ramp up data collection in May, and it remains unclear how long this will last. As you manage various contingency plans, please reach out if you want my help or need other support to manage adaptations to data collection plans.

ORSP is hosting a virtual **Research Town Hall** for faculty, staff, and researchers **Thursday, April 2nd, from noon – 1 p.m**. This is the <u>Zoom Invitation</u>. Staff from Sponsored Programs, Research Integrity & Education, the Institutional Review Board (IRB), the Institutional Biosafety Committee (IBC) and the Institutional Animal Care and Use Committee (IACUC) will be present to respond to your questions. Please send them your questions by Tuesday, March 31 at 5 p.m. <u>here</u>.

Immediately after, I will host a follow-up **Research-Forum** from **1:00pm to 1:30pm Thursday, April 2nd.** This is the <u>Zoom Invitation</u>. More dial-in details are at the end of this message. We can debrief and field any additional questions and resource needs. I am also collecting some tips and best practices on remote data collection approaches that I can share. Please share any resources you have found with me and I can compile them.

Communicate with the IRB, Funders, and Community Partners

If you are making changes to your research protocols, please be sure to communicate these changes with the IRB. You do not need permission ahead of time to move procedures to "remote" options, but you do need to communicate these changes within 10 days of their implementation. Other changes to protocols do need to be reviewed as usual by the IRB.

I know that your need to coordinate and communicate with funders and community partners varies, but please be sure to plan for how and when you will communicate any needed changes to these groups as well.
